### 16-18 Student Financial Support Policy 2019/2020

### Scope

This policy applies to students studying towards Education and Skills Funding Agency (ESFA) funded further education qualifications that also qualify for bursary support based on funding body criteria.

### **Policy context**

Vision West Nottinghamshire College policy is to follow the policy guidelines of the ESFA and openly, fairly and transparently apply the rules set by this government funding agency.

These funds are managed by the College and are allocated on a first come, first served basis (with the exception of the 16-18 Vulnerable Student Bursary Fund) via an application and assessment process. Students must meet the specified eligibility criteria in order to be considered for any assistance. The rules within this policy are set out at the time of writing and could be subject to change at any time from the ESFA.

Financial support is intended to remove barriers and support participation, attendance and achievement.

Applications received by the Student Financial Support Team will be processed within six weeks of enrolment. Any applications received prior to this will not be processed until after the student has enrolled. Applicants will be notified of their application outcome by post.

### Eligibility for 16 – 18 bursaries

To be eligible for the bursary students must:

- be aged 16 or over but under 19 at 31 August 2019
- meet the residency criteria in ESFA funding regulations for post-16 provision in the 2019 to 2020 academic year
- be participating in provision that is subject to inspection by a public body that assures quality (such as Ofsted), the provision must also be either;
  - o funded directly by ESFA or by ESFA via a local authority
  - $\circ$  funded or co-financed by the European Social Fund
  - otherwise publicly funded and lead to a qualification (up to and including level 3)
     accredited by Ofqual or on the ESFA list of qualifications approved for funding 16 to 19
  - o a 16 to 19 traineeship programme

Students on apprenticeship programmes, or any waged training, are employed, rather than in education. They are not eligible for the 16 to 19 Bursary Fund or Free Meals.

#### Students aged 19 and over at 31 August 2019 in the 2019 to 2020 academic year

Students who are aged 19 and over on 31 August 2019 are not eligible for support from the 16 to 19 Bursary Fund unless they:

- have an Education, Health and Care Plan (EHCP) and are attending eligible education provision; or
- are a student who is continuing on an eligible study programme they began aged 16 to 18 (19+ continuers)

No students aged 19 or over are eligible to receive a vulnerable bursary.

### 16-18 Student Support Fund for full-time students

To qualify for the bursary support you must have an annual gross household income of below £25,000 or below £30,000 with three or more dependent children, aged up to 19 and in full time education or below school age living in the household. Discretion may be given in extenuating circumstances.

For all applications (excluding Free College Meals) funding is limited; therefore evidence of eligibility does not guarantee an award. Student's wishing to apply for financial support should do so as soon as possible from the start of their course.

- £30.00 termly BACS payment to student bank account. Payment dates published and available to all students.
- Free college bus
- 100% support for essential kit and uniform (as specified by the Curriculum Area) internal transfer or reimbursement with receipts. Students who qualify for the bursary can have items purchased/reimbursed for them however, the items will remain the property of the college and they will be expected to return them at the end of the academic year or at any point should they withdraw. Kits/uniforms can be retained for further use to enable them to complete their studies if they are progressing onto the next level.
- 50% paid towards curriculum based trips to a maximum funding of £250.00 per year.
- UK University interview travel costs 50% of the total travel costs reimbursement with receipts and letter confirming interview date, time and venue. Public transport costs only.
- UCAS fee Pay 100% of fee of either £18 if application is for a single choice or £24 for more than one choice.
- Exams Pay 100% of exam <u>resit</u> cost for students in receipt of a bursary.

All above payments will be awarded based on 80% attendance rate except exam resit support which will have no attendance threshold.

- 100% support with transport for those that do not live on a college bus route mega-rider
  to be given where possible. Must live more than 1 mile away from college. Maximum 18
  mile radius from Derby Road campus.
- 100% support with transport for timetabled placement days. Students must provide a copy
  of their signed placement log to the student finance team for payment along with bus ticket.
- 100% support with transport for those whose timetabled hours include weekends or after
   5pm on weekdays.
- Young carers may be given support with transport even if they live on a bus route if this
  assists them with their caring responsibilities.

Full monthly payment in relation to transport costs is made if attendance is 90% or above. If attendance falls below 70% no payment is made. Attendance between 70% and 90% the student will receive that percentage of payment.

## **16-18 Vulnerable Student Bursary**

Students who meet one of the 4 criteria below and who have a financial need can apply for a bursary for vulnerable groups.

The defined vulnerable groups are students who are;

- in care
- care leavers
- receiving Income Support, or Universal Credit because they are financially supporting themselves or financially supporting themselves and someone who is dependent on them and living with them such as a child or partner
- receiving Disability Living Allowance or Personal Independence Payments in their own right as well as Employment and Support Allowance or Universal Credit in their own right

Please note that eligibility is no longer a guarantee of the full £1200 award from the vulnerable bursary fund. There is the possibility of a limited award or even no award at all if there is no financial need and/or the financial needs are covered from other sources.

The amount of any bursary award will be based on individual needs, which will include costs such as;

- Free college bus
- Transport costs for those that do not live on a college bus route mega-rider to be given
  where possible. Must live more than 1 mile away from college. Maximum 18 mile radius
  from Derby Road campus.
- Travel costs for timetabled placement days. Students must provide a copy of their signed placement log to the student finance team for payment along with bus tickets.
- Transport costs for those whose timetabled hours include weekends or after 5pm on weekdays.
- 100% support for essential kit and uniform (as specified by the Curriculum Area) internal transfer or reimbursement with receipts. Students who qualify for the bursary can have items purchased/reimbursed for them however, the items will remain the property of the college and they will be expected to return them at the end of the academic year or at any point should they withdraw. Kits/uniforms can be retained for further use to enable them to complete their studies if they are progressing onto the next level.
- £3.00 per timetabled days at college for a meal. The allowance will be credited weekly to the students Way2Pay account.
- Up to 50% paid towards curriculum based trips to a maximum funding of £250.00 per year.
- UK University interview travel costs 50% of the total travel costs reimbursement with receipts and letter confirming interview date, time and venue. Public transport costs only.
- UCAS fee Pay 100% of fee of either £18 if application is for a single choice or £24 for more than one choice.
- Exams Pay 100% of exam <u>resit</u> cost for students in receipt of a bursary.
- If a student has any further costs associated with their college course not covered by the support outlined above they must contact the Student Finance Team.

The award you receive will be based upon you attending all your planned classes, behaviour and discipline will also be taken into account. Your attendance will be monitored by the online college register system.

Full monthly payment in relation to transport costs is made if attendance is 90% or above. If attendance falls below 70% no payment is made. Attendance between 70% and 90% the student will receive that percentage of payment.

Students on study programmes of less than 30 weeks will be paid a pro-rata amount

#### **Free College Meals**

#### **Eligible benefits**

Free meals are targeted at disadvantaged students. Free meals in further education defines disadvantage as students being in receipt of, or having parents who are in receipt of, one or more of the following benefits:

- Income Support
- income-based Jobseekers Allowance
- income-related Employment and Support Allowance (ESA)
- support under part VI of the Immigration and Asylum Act 1999
- the guarantee element of State Pension Credit
- Child Tax Credit (provided they are not entitled to Working Tax Credit and have an annual
  gross income of no more than £16,190, as assessed by Her Majesty's Revenue and Customs
  (HMRC))
- Working Tax Credit run-on paid for 4 weeks after someone stops qualifying for Working Tax
   Credit
- Universal Credit with net earnings not exceeding the equivalent of £7,400 pa

A student is only eligible to receive a free meal when they, or a responsible adult on their behalf, have made a successful application to Vision West Nottinghamshire College.

- Payment will be made to students aged between 16 and 18 on 31<sup>st</sup> August 2019 who are or whose parent/carer are in receipt of qualifying benefit.
- Students aged 19 or over are only eligible for a free meal if they or their parent/carer are in receipt of a qualifying benefit and they:
  - Are continuing on a study programme they began aged 16 to 18 ('19+ continuers')
     or
  - Have an Education, Health and Care Plan (EHCP)
- The payment will be £3.00 per timetabled days at college.
- The allowance will be credited weekly to students Way2Pay accounts.
- Eligible students attending placement can receive payment of £3.00 per day paid into their nominated bank account on production of a copy of their signed placement log to the student finance team for payment.
